# The Act

Simplifies social care law and is intended to deliver:

- Stronger voice and more control, for people, over their lives
- Well-being and personal outcomes
- Improve service coherence and consistency across Wales
- Build on the strengths of communities - knowledge and experience

# Mae'r Ddeddf

Yn symleiddio cyfraith gofal cymdeithasol a'i bwriad yw sicrhau:

- Llais cryfach a mwy o reolaeth i bobl, yn ystod eu hoes
- Lles a chanlyniadau personol
- Gwella cydlyniad gwasanaethau a chysondeb ar draws Cymru
- Adeiladu ar gryfderau cymunedau – gwybodaeth a phrofiad

# Principles

- **People** - putting the individual and their needs, at the centre of their care, and giving them a voice in, and control over reaching the outcomes that help them achieve well-being
- **Well-being** – supporting people to achieve their own well-being and measuring the success of this care and support

# Egwyddorion

- **Pobl** - sicrhau bod unigolyn a'u hanghenion wrth wraidd eu gofal, a rhoi llais a rheolaeth iddynt dros gyrraedd y canlyniadau i helpu eu lles
- **Lles** – cefnogi pobl i gyflawni eu lles eu hunain a mesur llwyddiant y gofal a'r gefnogaeth hon

# Principles

- **Earlier intervention** - increasing preventative services within the community to minimise the escalation of critical need
- **Collaboration** – Strong partnership working between all agencies and organisations

# Egwyddorion

- **Ymyrraeth gynharach** - cynyddu gwasanaethau ataliol yn y gymuned i leihau'r cynnydd mewn angen critigol
- **Cydweithio** – Yr holl asiantaethau a sefydliadau i weithio mewn partneriaeth gadarn

# Outcomes


- Improve well-being for those needing care and support, and carers
- Ensure preventative and information services are locally available
- Keep children and adults safe
- Ensure organisations work together
- Give people more say and more control
- Delivers more rights to carers

## 2014-15: Adults

- Local authorities assessed the needs of 83,100 adults
- At 31 March 2015 nearly 73,900 adults receiving services
  - 82% were receiving community-based services
  - 18% were in care homes
- In a sample week in September 2014, nearly 23,000 adults received home care

## 2014-15: Oedolion

- Fe wnaeth awdurdodau lleol asesu anghenion 83,100 o oedolion
- Ar 31 Mawrth, 2015 roedd bron i 73,900 o oedolion yn derbyn gwasanaethau
  - Roedd 82% yn derbyn gwasanaethau yn y gymuned
  - Roedd 18% mewn cartrefi gofal
- Mewn wythnos enghreifftiol ym mis Medi 2014, roedd bron i 23,000 o oedolion yn derbyn gofal cartref

## 2014-15: Children & Young People

- LAs in Wales received over 35,400 referrals in the year
- 27,200 initial assessments completed
  - 76% carried out within 7 working days
  - 81% of core assessments completed within 35 working days

## 2014-15: Plant a Phobl Ifanc

- Derbyniodd Awdurdodau Lleol yng Nghymru dros 35,400 o atgyfeiriadau yn ystod y flwyddyn
- Cwblhawyd 27,200 o asesiadau cychwynnol
  - Cwblhawyd 76% o fewn 7 diwrnod gwaith
  - Cwblhawyd 81% o asesiadau craidd o fewn 35 diwrnod gwaith

## 2014-15: Children & Young People

- 2,936 children on Child Protection Registers at 31 March 2015
  - 31% of children on CPRs for less than 3 months
  - 16% of children on registers for 12+ months

## 2014-15: Plant a Phobl Ifanc

- Roedd 2,936 o blant ar y Gofrestr Amddiffyn Plant ar 31 Mawrth, 2015
  - Roedd 31% ar Gofrestru Amddiffyn Plant am lai na 3 mis
  - Roedd 16% o'r plant ar gofrestrau am 12+ mis

# Dementia

- Over 43,000 people living with dementia in Wales
- Dementia more common as people age:
  - One in 6 people over 80
  - One in three people over 95 has a form of dementia
  - 66% of older people in residential care have dementia

# Dementia

- Mae dros 43,000 o bobl yn byw gyda dementia yng Nghymru
- Mae Dementia yn fwy cyffredin wrth i bobl heneiddio:
  - Mae un o bob 6 o bobl dros 80
  - Un o bob tri o bobl dros 95 oed yn dioddef o fath o ddementia
  - Mae 66% o bobl hŷn mewn gofal preswyl yn dioddef o ddementia

# Dementia

- The number of people with dementia across Wales is projected to increase by 31% and by as much as 44% in some rural areas by 2021





## Must Do's

- Respect people's views, wishes and feelings
- Promote and respect dignity - including culture, beliefs and language
- Promote independence where possible
- Provide support to enable people to fully participate in decisions that affect them

## Must Do's

- Accept that people are best placed to judge their own well-being
- Shift the balance of power to local communities, tailoring solutions to local circumstances
- Encourage local people and businesses to more actively engaged in their communities

- Derbyn mai'r bobl sydd yn y sefyllfa orau i farnu eu lles eu hunain
- Symud y cydbwysedd grym i gymunedau lleol, gan deilwra atebion i amgylchiadau lleol
- Annog pobl a busnesau lleol i chwarae mwy o ran yn eu cymunedau

## Must Do's

- Open up public services, including enabling mutual enterprises to engage activity in the delivery of social care and wellbeing
- Create and develop new synergies and partnerships and a national/regional delivery model

## Rhaid...

- Agor y gwasanaethau cyhoeddus, gan gynnwys galluogi mentrau cydfuddiannol i chwarae mwy o ran yn nhermau darparu gofal cymdeithasol a lles
- Creu a datblygu synergieddau a phartneriaethau newydd a model cyflenwi cenedlaethol / rhanbarthol

- Training resources and support to help workforce adapt to the changes, and lead communication with the public

- Consistent leadership – ADSS Cymru/WLGA
- Continuing to revert to unhealthy ‘default positions’ - blame still alive and kicking
- Stressed workforce working hard to stand still
